Note:

- 1. The Certification Fee consists of Registration Fee and Assessment Fee. Registration Fee is determined by and payable to the HKGBC. Assessment Fee is determined by and payable to BEAM Society Limited. Both organisations reserve the right to adjust the respective fees.
- 2. The Registration Fee for NB projects is a one-off payment payable to the "Hong Kong Green Buildin Couns Vimited". Payment shall be made within 90 calendar days of the date of Payment Advice, failing which we reserve the right to tharge the prevailing Registration Fee at the time of receipt of payment.
- 3. The Assessment Fee for NB indicated in the above covers both the assessment fee for Pt vision Assessment (PA) and Final Assessment (FA).
- 4. For projects with Construction Floor Area larger than 600,000 sq. m., registration to the Example of Example of Scale / Complexity (ExS) shall apply, while BEAM Society Ltd reserves the right to negotiat the assignment fees for these larger developments to ensure a practical and equitable fee level.
- 5. If Provisional assessment (PA) has been commenced, it is deemed that the personal vervice is consumed and there is no proportional refund of the assessment fee. The Applicant is required particle full PA assessment fee for the new round of PA at prevailing fee scale.

Remarks:

- (i) An applicant may apply for a 50% discount on Pressure Fee rovided that the following three conditions are simultaneously met: (a) the building owner is a charable organisation which is exempt from tax under Section 88 of the Inland Revenue Ordinance; (b) the building owner was not recurse external subsidy from the government or other public sources of fund to cover the expense of that particule, project; and (c) the building is not built for generating commercial income.
